PERMIT IS APPROVED WITH CONDITIONS AND PROVISIONS LISTED BELOW:

- St. Johns County reserves the right to modify the permit based on verifiable need & availability.
• Lessee must provide a practice schedule prior to the start of the season.
• Lessee must provide a game schedule no less than 1 week in advance of the first game.
• Lessee must provide a light schedule no less than 1 week in advance.
• Lessee must notify staff of schedule changes and/or field cancelations in real time.
• Lessee must notify staff of rescheduled games 1 week in advance.
• Lessee must obey all SJC Parks & Recreation rules to include all aspects of safety, including during inclement weather.
• Lessee must keep athletic fields and facilities clean, pick up trash & dispose of properly and put away equipment properly after each use.
• Lessee must be respectful of other athletic group's equipment, field space and scheduled activities.

ADDITIONAL PERMITS AND PROVISIONS THAT MAY APPLY ARE CHECKED BELOW:

- [x] Lessee must provide a player roster in excel format that includes players first/last name, address and zip code.
[x] Lessee must provide a team roster in excel format that includes players name, coaches name & contact info.
[] Tournament applicants must coordinate with staff to determine maintenance staffing requirements & need for port-o-lets and/or dumpsters 14 days prior to the event.
[] Maintenance staff will not line baseball/softball fields for practices. League must submit game schedule 1 week prior to game to schedule the lining of baseball/softball fields.
[x] Lessee must follow CDC Guidelines for youth sports activities to include social distancing of 6' or more, sanitizing and disinfecting areas/items used by participants, hand sanitizing stations.
[x] Lessee must frequently move goals, alternate training patterns, be mindful of wear in coach's boxes to reduce wear & tear on fields.
